**Please can you describe how you plan on conducting data collection using these methods:**

I will conduct interviews with both individuals who have experienced modern slavery, at the time these survivors had irregular immigration status', however, they are now regularised and have previously disclosed their experiences of modern slavery. I will also interview a number of individuals working for civil society groups and charities with a focus on immigration detainees. This is to obtain greater insight into the experiences of detainees who have survived modern slavery, and obtain information of possible wider patterns of concern with the policy.

Before conducting the interviews I will send each interviewee an overview of the research, what I hope to find and my abstract. This will lay out how all interviewee's will be anonymised, that information will be securely held.
